

IMPORTANT INFORMATION

Travel One feels that the camp discounted fares will be the best fare available for all campers.

Along with these Northwest discounted fares, however, come restrictions. The rules are listed below. Please bear that in mind when making your arrangements, and **please respond as quickly as possible**, since timing is important.

THE RULES ARE AS FOLLOWS:

1. For best fares tickets should be issued at least 30 days prior to departure. **Please respond promptly.**
2. Once tickets are issued, they are non-refundable. The ticket can be reused for a \$50.00 to a \$100.00 change fee.
3. Valid on Northwest Airlines only. **In most markets a Saturday night stay is no longer required.**
4. Special Northwest fares can be issued only by Travel One.

Those families who cannot respond within this time frame will still be able to use the appropriate camp flights. The cost of your airfare is dependent on the lowest fare available at time of booking. You will receive the camp discount off of most fares. The sooner you book your reservation, the more likely the lower fares will be available.

By promptly returning the enclosed travel reservation form, you are asking Travel One to secure for your youngster the lowest applicable airfare. **(Airline penalties will occur if you change or cancel your child's itinerary.)**

PLEASE EXAMINE THE ENCLOSED FLIGHT SCHEDULE CAREFULLY

If your departure/return city is listed, you will have knowledge of the flights your camper will be using. Please respond with your credit card information and Travel One will secure the absolute best fare available. If you want to know the exact fare, you may contact Travel One and place your reservation.

If your city does not fly Northwest or you do not find your city listed on the flight schedule, also return your reservation form indicating your desired departure/return city. Please enclose the proper credit card information as requested on the travel reservation form. Upon receipt of your reservation form, Travel One will promptly contact you and make travel arrangements. Travel One, in conjunction with Camp Lincoln and Lake Hubert, has selected flights that best fit into the arrival and departure time schedule for the camp. We will do our best to have all children from all the same destinations sit together on the airplane. This can be best accomplished if the tickets are purchased at the same time.
