

APPLICATION DETAILS

- The camps are open to boys and girls of good character. We reserve the right to accept or reject applicants. Spiritually, our camps are Christian; however, we endeavor to maintain a cross section of the very best of American life in balance with the best interests of all camp participants.
- Filing application implies understanding, by camper and parents, of our policy that there shall be no smoking, chewing tobacco, drinking of alcoholic beverages, or possession of or use of illicit drugs during the camp session. We reserve the right to dismiss any camper whose action, behavior or attitude, in our judgment, is contrary to the best interests of camp.
- Enrollment is limited in some camps, based on age/grade and spaces available, especially in some of the short term camps. Waiting lists are accepted on all camps.
- We practice safety at all times, to the best of our ability; however, participation in camp life and activities has inherent risks and injuries sometimes do occur. With enrollment, parents acknowledge and accept this fact and agree to hold harmless the camps, its employees, and agents against any and all claims, damages and injuries.
- A resident medical staff is available for routine medical services, but the cost of special medications, illness expenses, hospital costs, or consulting doctors are not included in the camp fee.
- We cannot be responsible for clothing, watches, jewelry, electronics or other personal property brought to camp. We will deposit any valuables in our camp safe if turned over to us on arrival. We highly recommend the use of name tapes for marking clothing and gear.
- Camp preparation materials, including Parent Handbook, clothing/equipment lists, medical form, shipping tags and transportation information will be sent in early spring. Applicants accepted after any of these mailing dates will receive these materials along with the letter of acceptance.
- A successful camping experience and partnership with parents is the result of mutual confidence and cooperation. We pledge you our best and ask that you cooperate with us in terms of supplying information requested and honoring camper and parent expectations as outlined in our Parent Handbook.

8 Weeks: The true traditional camp experience! Available for girls who are current 4th through 9th graders, and for boys who are current 2nd through 9th graders.

4 Weeks: The classic camp experience. Available for girls who are current 4th through 11th graders, and for boys who are current 2nd through 11th graders.

3 Weeks: A traditional, yet shorter, camp experience. Available for girls who are current 4th through 7th graders, and for boys who are current 2nd through 6th graders.

2 Weeks: An opportunity to experience first-hand the benefits of traditional camping. Available for girls who are current 2nd through 6th graders. Available for boys who are current 2nd through 6th graders for 2W1 and 2W2 and for boys who are current 2nd through 5th graders for 2W3 and 2W4.

Intro: A fun and structured introduction to the camp experience. Available for girls and boys who are current K through 3rd graders.

Coed: A short term traditional camp with a coed setting. Available for current 2nd through 8th graders.

Family: The whole family will enjoy the camp experience. Available for parents, grandparents and children of all ages.

- The application and deposit constitute an enrollment agreement only when accepted by a Camp Lincoln and Camp Lake Hubert Director in writing and shall be construed in and under the laws of the State of Minnesota. Any controversy or claim arising out of or relating to this enrollment agreement or the breach thereof which cannot be resolved in accordance with the terms hereof shall be filed with and settled by the American Arbitration Association's Minnesota Regional Office in accordance with the then existing Rules of the American Arbitration Association, and any award rendered by the arbitrator or arbitrators may be entered in either the District Court of Crow Wing County, Minnesota, or the United States Court, District of Minnesota. This agreement shall be construed and enforced in accordance with the laws of the State of Minnesota. We consider your enrollment and/or payment as acknowledgement and acceptance of all the terms of this agreement.
- It is understood by parents and campers that any video, portraits or pictures of the camper taken at camp and quotes or other written materials may be used by Camp Lincoln and Camp Lake Hubert or assigned agents for art, advertising and promotional information. Parents and campers waive the right to inspect and/or approve the finished product or copy. A list of camper names and addresses may be distributed for camper's use.

No reduction of tuition is made for late arrival, early departure or dismissal. Cancellation Fees are not reduced for medical reasons.

Multiple Sibling Discount: For those families enrolling more than one child in one of our traditional camps, we are pleased to offer a \$50 discount for each subsequent sibling enrolled.

Deposit for Miscellaneous Expenditures: An expense deposit is required in addition to the camp tuition. This deposit payment is required in advance, to serve as a drawing account for the camper. The first statement will invoice the estimated deposit for expenditures for the session in camp, i.e.

\$300.00	for 3 and 4 Weeks Camps
\$400.00	8 Weeks Camp
\$250.00	for 2 Weeks Camps
\$150.00	for Intro and Family Camps

Items charged against this account when applicable: camp store items; local and special trips; cash withdrawals; chartered bus

to/from Mpls/Airport; laundry; yearbook; bedding; medical prescriptions and illness expense. Campers who participate in some of our special trips (canoeing, backpacking, kayaking, rafting, chartered sailing, climbing, etc.) can expect an additional pro-rated charge per trip which could cause expenses to exceed the recommended deposit.

Only those services actually used or items purchased will be charged and any balance remaining will be refunded or overdraft will be billed in late September.

TRANSPORTATION DETAILS

Detailed transportation information will be sent with the Parent Information Packet. This packet is mailed in early spring or after enrollment and includes specifics on air travel, chartered bus service from the airport or the Minneapolis/St. Paul, Minnesota area and driving information.

We coordinate air travel arrangements through Travel One (1-800-245-1111). Please use this service as it benefits you and allows us to coordinate all of our camper's transportation.

Travel One's experience and knowledge of the air travel market (i.e., special baggage handling, group seating, special fares, seat allocations, etc.) provide maximum convenience, service and safety for each of our campers. As the summer approaches, please check with the airlines for current details.

We will meet all campers at the gate upon arrival at the Minneapolis/St Paul Airport and put all campers on the plane at departure. Chartered bus service to and from camp for all airport campers is provided at a nominal charge. Chartered bus service is also available at a nominal charge from a Minneapolis suburban location for local campers.

Plan arrival at the Minneapolis/St. Paul International Airport between 9:00 am and 2:00 pm on Opening Day.

Plan departure from the Minneapolis/St. Paul International Airport between NOON and 4:00 pm on Closing Day.

Requests to arrive or depart outside of these times, or on days other than the scheduled arrival and/or departure day, will need the prior approval of a Camp Director. Camp Director Approval is also needed if you wish to pick up your camper for an event during the camp session. Please submit requests at your soonest convenience, and at least 30 days prior to the camp session. Failure to gain approval may cause the cancellation of the registration, subject to our cancellation policy.
