SPECIAL FARES FOR CAMP LINCOLN AND CAMP LAKE HUBERT ON DELTA

Just as Travel One is camp's travel agency of preference, Delta Air Lines is camp's airline of preference. Delta Air Lines has provided Camp Lincoln and Camp Lake Hubert with discounted camp fares that should be cost competitive with any airfare offered for similar summer travel. These special fares are in the form of an up-front discount which will be applicable to the lowest Delta Air Lines fare available at time of booking. Suggested flights and restrictions are posted on the camp website.

In addition to the special negotiated camp fares, Delta Air Lines assists with the luggage collection process upon arrival into Minneapolis and provides special assistance with luggage handling and check-in procedures on camp departure days. Campers bypass normal Delta check-in procedures.

SOUTHWEST AIRLINES SERVICES MINNEAPOLIS/ST. PAUL

Southwest now offers non-stop service between Minneapolis/St. Paul Hubert Humphrey Terminal #2 and many camp cities. Camp will also meet your camper at the gate if the arrival is at Hubert H Humphrey Terminal. Air fares are similar between Southwest and Delta, but Southwest has a more attractive unaccompanied minor and luggage fee program. Keep in mind that Southwest will only allow unaccompanied minors on direct flights. **Travel One issues tickets on Southwest Airlines as well as all other airlines.**

TAXES, AIRPORT FEES AND TRAVEL AGENCY FEES

When Travel One quotes an airfare, it will include a nominal \$25.00 travel agency fee. If you choose to pay for your ticket via credit card, this \$25.00 agency fee may appear as a separate billing item. The camper's family is also responsible for the round-trip unaccompanied minor service fee, if applicable. This is payable at the airport prior to departure. Delta Air Lines (all major airlines) charges luggage fees of \$30.00 for the first checked bag and \$40.00 for the second checked bag for each way of travel.

UNACCOMPANIED MINOR INFORMATION

As a camp traveler, you must check-in at the airline ticket counter to process the unaccompanied minor paperwork. Please allow additional time for the airport check-in procedure (a minimum of 120 minutes). A camp representative **will be** at the gate in Minneapolis to meet your child. The latest information concerning unaccompanied minor travel is enclosed with this mailing. Three weeks prior to departure, Travel One will mail your E-ticket receipt and any additional or updated information.

The Transportation Security Administration (TSA) now requires the traveler's full legal name and date of birth when making reservations.

DELTA AIR LINES UNACCOMPANIED MINOR

CAMPERS AGES 14 YEARS AND UNDER MUST TRAVEL AS UNACCOMPANIED MINORS OR ACCOMPANIED BY ANOTHER TRAVELER 18 YEARS OF AGE OR OLDER

Airlines have instituted strict regulations regarding security and unaccompanied minors. Delta Air Lines requires passengers ages 14 and under to be accompanied by another individual 18 years of age or older **or** purchase unaccompanied minor services from that airline.

IMPORTANT: Delta and most airlines will allow up to four children, both family and non-family members, to travel under the cost of one unaccompanied minor service, but only one parent/adult will be allowed to accompany all the children to the gate. **The children must check-in together both at the airport check-in counter and at the gate. Travelers must all be listed on the same unaccompanied minor form.**

On the return flight, one adult taking responsibility for all the children on the unaccompanied minor form **must be present at the airport to pick up the minors.** If the specified adult is not present at the airport, Delta or other airlines will not release the children.

The family should purchase this service on a **round-trip basis** unless the camper is only traveling one way. The cost is \$150.00 one way or \$300.00 round trip for both non-stop and connecting flights.

Delta is using a barcoded wristband that will be scanned at important points of the Unaccompanied Minor's journey. Scan events allow Delta to have added visibility to the minor's location while traveling.

When checking in an unaccompanied minor, you will need the following information so that a camp representative can meet your child at the gate.
